MEMORANDUM OF UNDERSTANDING (MOU)

Between

KIRIROM INSTITUTE OF TECHNOLOGY (KIT)

And

NTC GROUP (NTC)

ARTICLE

Kirirom Institute of Technology (KIT) which located in Preah Soramarith Kosomak Kirirom National Park, Phnom Srouch District, Kampong Spue Province and **NTC Group (NTC)** which located on #100, Street Pasteur (St. 51 – St. 200), Sangkat Phsar Thmei III, Khan Daun Penh, Phnom Penh City, Cambodia *would like to strengthen* wishing to strengthen the bilateral relationship in helping to develop human resource in Cambodia with a view of upgrading the relationship and cooperation between KIT and NTC, have agreed to sign this Memorandum of Understanding. *NTC*

The cooperation may extent to any fields and subject which two parties may identify as shared interests. Cooperation in specific areas must be designated by mutual consent and incorporated into specific addition written agreement.

Two parties agree to the following:


1. KIT will offer the full scholarship to the students under NTC Group at least 10 seats every year on the condition that NTC provides qualified students who meet KIT's math, English, and IQ requirements and pass the interview for IT program and qualified students who meet KIT's Hospitality Leadership Management requirements that include English, IQ Test, EQ Test, and passing interview.
2. KIT will provide waiver English Test to NTC group's students who has 3.5 Points IELTFS Test or 30 Score of TOEFL Test which provided specific certificate or certified letter from NTC Group or school under NTC Group.
3. NTC group will promote KIT to their students and provide at least two opportunities per year for KIT to do seminars at NTC site for NTC students regarding KIT's IT and Hospitality Leadership Management programs.
4. NTC will provide testing site at NTC specifically for their students and KIT will responsible for examination facilitation team and arrangement.
5. NTC Group and KIT will have the option to promote each other on their respective websites as strategic and strong partners.
6. NTC group's students will be get scholarship unless they need to pass from KIT examination test as below:
 - a. IQ, Mathematic, and oral interview on the skill of Software Engineering for getting this scholarship.
 - b. IQ, EQ, and Oral Interview on the skill of International Hospitality Management

- c. In case students from NTC does not has certified letter mention in point number 3 they shall be pass our English Test from KIT.
7. KIT will offer free services items for scholarship as below:
- Free tuition fee and other admission fee for study 4 years in KIT.
 - Free accommodation in Campus.
 - 3 times meals complementary at Campus's canteen.
 - Free 18 times ticket for Transportation (Phnom Penh-Kirirom-Phnom Penh) by company settle bus.
 - Provide computer (Laptop) and iPad/Tablet for study.
 - Provide Accident Insurance 24H/7 for 4 Years.
 - Do best to provide opportunity to work in oversea.
 - After pass the scholarship the students have to sign on the scholarship agreement letter for accepting scholarship and implementing follow to the conditions of the agreement accordingly.
8. School Trip will be conduct for the students and their guardians in order to inspect the KIT. KIT will offer discount 50% for Resort Services such as meal and other entertainment activities with team facilitate for the campus visit, for transportation NTC is own responsibility.

This MOU shall be effective upon exchange signature by representative of both institutions. Both Parties jointly commit to the term as specified in this MOU for a period of year 2019-2022. This MOU is made in English in Two (2) Copies, one of which is kept by each institution.
