

Memorandum of Understanding  
between  
SAHAKUM NEWTON THILAY GROUP Co., Ltd, Cambodia  
and  
National Cheng Kung University, Taiwan

**1. Preamble**

In accordance with the mutual desire to foster cooperation between SAHAKUM NEWTON THILAY GROUP Co., Ltd (Cambodia; hereinafter referred to as "NTC GROUP"), and National Cheng Kung University (Taiwan; hereinafter referred to as "NCKU"), and in order to explore potential collaborations in the areas set out below, the two institutes agree to the following terms.

**2. Areas for Potential Collaborations**


- (1) Student scholarships and applications
- (2) Exchange of academic and administrative experiences by faculty and staff, and personnel development
- (3) Visits of students and study tours, and management visits
- (4) Student sharing sessions
- (5) Internship opportunities
- (6) Promotion and exchange of programs
- (7) Promotion of cultural activities between the two institutes


**3. Implementation of Memorandum of Understanding**

Both institutes agree that specific projects and activities shall be developed for the implementation of this Memorandum of Understanding, based on discussions and negotiations between the two institutes. Agreements or contracts shall be signed separately to carry out these projects and activities. Both institutes agree that all financial arrangements shall be determined based on specific projects and activities, and will depend on the availability of funds.

This Memorandum of Understanding shall be in force for a period of three years from the date of its enactment, and shall be renewable by mutual consent at the end of that period for a second three-year period. This Memorandum of Understanding may be terminated prior to that time on the condition that a notice of intent to terminate is provided by the initiating party at least six months prior to termination. This agreement may be amended or modified at any time by the mutual consent of the cooperating parties.

If this Agreement is executed in more than one language, the English version shall control in the event of inconsistency in meaning or interpretation of terms.

## Appendix A

During the period of this Memorandum of Understanding, the NTC Group and NCKU agree to offer the following:

1. NCKU would allocate available resources, upon request, to promote NCKU's academic programs applicable for NTC Group Students.
2. NCKU would allocate available resources, upon request, to conduct student sharing sessions for NTC Group Students about NCKU's programs and all eligible scholarship opportunities on mutually-agreed dates.
3. NTC Group would provide opportunities for internship and exchange programs for NCKU students at NTC campuses, upon further discussion and agreement.
4. NTC Group will open their door for management visits from NCKU and academic visits by NCKU students to NTC campuses and Cambodia.
5. NCKU would provide for 2 students from NTC Group Students to join the international summer school program, including application fee, program fee, Chinese language & culture class fee, on-campus accommodation and city tour-Tainan city fee per year. NTC Group student is responsible for his/her own international and local transportation expense, food expense and sufficient medical insurance to cover his/her own medical behaviour.
6. NCKU would allocate NTC Group delegation visits to NCKU. NCKU would provide the local transportation and accommodation; the maximum number of delegation member is 5 people by contract.
7. NTC Group Students are eligible to apply NCKU distinguished International Student Scholarship. The scholarship is determined by the department decision.
